PRIVACY POLICY

- **1. Introduction.** Welcome to Hire My Online Professor's Assistant ("Hire My Online"). We are committed to protecting your privacy and ensuring the security of your personal information. This Privacy Policy (the "Policy") explains how we collect, use, maintain, disclose, and protect your information when you use our products and services (users of the Site are referred to collectively as "Users," and individually a "User"). By using our website (https://hiremyonline.com) (the "Site"), products and/or services, you agree to the terms outlined in this Policy. If you do not agree to this Policy, please do not use our Site and/or the products and services of Hire My Online. This Policy may change from time to time as stated below. Your continued use of the Site and/or the products and services of Hire My Online following the posting of changes to this Policy will be deemed to constitute your acceptance of those changes, so please check this Policy periodically for updates.
- **2. Information We Collect.** We collect various types of information to provide and improve our products and services, including:
 - Personal Information: This includes your name, email address, phone number, billing information, and other details you provide during registration or use of our products and services. We may use your Personal Data to contact you with newsletters, marketing and/or promotional materials and other information that may be of interest to you. - **3. Web Browser Cookies.** Our Site may use "cookies" to enhance User experience. The User's web browser places cookies on the User's hard drive for record-keeping purposes and, on occasion, to track information about the User's activity. Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyze our products and services. We may receive reports based on the use of these technologies by these companies on an individual or aggregated basis.

- **4. How We Use Your Information.** We use the information we collect to:
 - Provide, maintain, and improve our products and services.

- Personalize your experience and offer customized content.
- Process transactions and send related information, such as purchase confirmations and invoices.
- Communicate with you, including sending promotional materials and updates.
- Monitor and analyze usage and trends to improve our products and services.
- Enhance the security and protection of our services and users.
- **5. Sharing Your Information.** We do not sell or rent your personal information to third parties. However, we may share your information in the following circumstances:
 - **Service Providers:** We may share information with third-party vendors who perform services on our behalf, such as payment processing, data analysis, and customer support.
 - **Legal Requirements:** We may disclose your information if required by law or in response to legal processes, such as a court order or subpoena.
 - **Business Transfers:** In the event of a merger, acquisition, or sale of assets, your information may be transferred to the new owner.

You hereby release, discharge and forever acquit Hire My Online, its directors, officers, owners, employees, volunteers, independent contractors, agents, assigns, successors and consultants associated with Hire My Online from any and all liability, claims, demands, actions and causes of action whatsoever, arising out of or related to any economic or property loss, damage or injury that may be sustained by You through Hire My Online' use of any third-party payment processor services of any kind.

- **6. Data Security.** We implement reasonable security measures to protect your information from unauthorized access, use, or disclosure. However, no data transmission over the internet or storage system can be guaranteed to be 100% secure. When a User utilizes the services of Hire My Online, Hire My Online will maintain the user's contact information and servicing information for its records unless and until the user asks Hire My Online to delete such information. No security measures are 100% reliable, however, so we cannot guarantee the security of your data.

Under the GDPR, you have the following specific rights: (a) the right of access; (b) the right to rectification; (c) the right to erasure; (d) the right to restrict data; (e) the right to object; (f) the right to data portability; and (g) the right to complain to Company's internal compliance officer. 11. California Residents Under the California Consumer Privacy Act ("CCPA").
